Subject: Admission in Medical Colleges/ Other Educational Institutions of Pakistan by Indian Citizens - regarding.

Sir,

I am directed to say that AICTE vide its letter No. F. No. 3-1IMS/CORR/202L-22 dated 29.12.2021 has intimated that Ministry of External Affairs had requested AICTE to issue notice for the students who wish to pursue Engineering from Pakistan on the lines of the Public Notice issued by National Medical Commission of India. Accordingly, a Public Notice was issued by AICTE in National Dailies in the month of November, 2021 for the students who wish to pursue Technical Education abroad particularly in Pakistan (Copy enclosed). Through this public notices it was communicated to all the students, who wish to pursue Technical Education in Pakistan, that they shall require to obtain NoC from AICTE for which prescribed form is available on AICTE website.

- It has been further stated by AICTE that some students may seek admissions in 2. Pakistan in other courses like Pharmacy, Applied Arts & Crafts, Nursing, Science and Humanities etc. At present, there is no mechanism to track such students. So it is suggested that a mechanism to track such students can be created through immigration while leaving India from airport. Although AICTE has already issued a Public Notice in this regard and sent it to all colleges, however, as they are going after XII it is felt that this information may be shared at the school level and such notices may be sent to all schools in the country so that students are aware at that stage.
- 3. It is, therefore, to take necessary action in the matter as suggested by AICTE.

AICTE received a communication from Ministry of External Affairs in the year 2020 regarding students of J&K and Ladakh taking admission in unapproved institutions operated in PoJ&K.

Accordingly, an advisory through Public Notice was issued by AICTE for the students against taking admission in any of the courses of Technical Education in the territory under illegal occupation of Pakistan including so called AZAD J&K (AJ&K), Gilgit & Balistan which are currently not recognised in India. Copy of the Public Notice is enclosed.

Another communication was received from the Ministry of External Affairs in October, 2021 asking AICTE to issue notice for the students who wish to pursue Engineering from Pakistan on the lines of the Public Notice issued by MCI. Accordingly, a Public Notice was issued in National Dailies in the month of November, 2021 for the students who wish to pursue Technical Education abroad particularly in Pakistan. Through this public notices it was communicated to all students who wish to pursue Technical Education in Pakistan shall require to obtain NoC from AICTE for which prescribed form is available on AICTE website. So far no request has been received from any student in this regard. Copy of Public Notice is enclosed.

It is further informed that some students may seek admissions in Pakistan in other courses like Pharmacy, Applied Arts & Crafts, Nursing, Science and Humanities etc. At present, there is no mechanism to track such students. So it is suggested that a mechanism to track such students can be created through immigration while leaving India from airport. All though AICTE has issued a Public Notice in this regard and sent it to all colleges, but they are going after XII and hence it is felt that this information may be shared at the school level and such notices may be sent to all schools in the country so that students are aware at that stage.

Association of Indian Universities (AIU) gives equivalence for the Foreign Qualification and hence may be asked to look for the clearance / NoC issued by respective regulatory body before awarding the equivalence to the degrees obtained from Pakistan.

PURSUING TECHNICAL EDUCATION ABROAD

The instances have been noticed where students going to Foreign Countries for obtaining UG & PG Degrees in Technical courses which are not recognized and students run from pillar to post for their authentication and equivalence. The validity/ equivalence of such Foreign degrees awarded are at times not at par with the degrees awarded to students passed from Indian Institutions. Such students after obtaining degrees from Foreign Universities are facing issues in getting the opportunities in India (Government/Private sector) jobs or higher education even after spending huge amount of fee to obtain such non-equivalent technical degree. AICTE has taken cognizance of the above issue and in order to avoid financial burden on parents of such students, is issuing the warning that student must carefully ensure the validity of the degree.

An Indian National/ Overseas citizen of India who intends to take admission in Higher education in Engineering & Technology Programme in Pakistan shall require to obtain No Objection Certificate from AICTE. The student should apply for such clearance in prescribed proforma available on AICTE website.

विदेश में तकनीकी शिक्षा प्राप्त करना

कई ऐसी घटनाएँ ध्यान में आई हैं कि विद्यार्थी तकनीकी पाठ्यक्रमों में रनातक (यूजी) और रनातकोतर (पीजी) डिग्री प्राप्त करने के लिए विदेश जाते हैं तथा उनके द्वारा प्राप्त की गई डिग्रियों के मान्यता प्राप्त नहीं होने के कारण विद्यार्थियों को उन डिग्रियों के प्रमाणीकरण और समकक्षता के लिए दर-दर की ठोकरें खानी पड़ती हैं। कई बार उन्हें प्रदान की गई ऐसी विदेशी डिग्रियों की वैधता / समकक्षता भारतीय संस्थानों से उत्तीर्ण छात्रों को प्रदान की गई डिग्री के बराबर नहीं होती हैं। जिसके कारण इस तरह की गैर-समकक्षता वाली तकनीकी डिग्री प्राप्त करने के लिए भारी मात्रा में शुल्क खर्च करने के उपरांत भी ऐसे विद्यार्थियों को विदेशी विश्वविद्यालयों से डिग्री प्राप्त करने के बाद भारत में नौकरियों (सरकारी / निजी क्षेत्र) अथवा उच्च शिक्षा में अवसर प्राप्त करने में समस्या का सामना करना पड़ रहा है। अभातिशिप द्वारा उक्त मुद्दे का संज्ञान लिया गया है और ऐसे विद्यार्थियों के माता-पिता का उन पर पड़ने वाले वित्तीय बोझ से बचाव करने के लिए अभातिशप द्वारा चेतावनी जारी की जा रही है कि विद्यार्थी ऐसी डिग्री प्राप्त करने से पूर्व उसकी वैधता की सावधानी पूर्वक जाँच सुनिश्चित कर लें।

किसी भी ऐसे भारतीय नागरिक / भारत के प्रवासी नागरिक द्वारा, जो पाकिस्तान में इंजीनियरिंग और प्रौद्योगिकी कार्यक्रम हेतु उच्च शिक्षा में प्रवेश प्राप्त करना चाहतें हैं, अभातिशप से अनापित प्रमाण पत्र प्राप्त किया जाना अपेक्षित है। इसके लिए अनुमित प्राप्त करने हेतु विद्यार्थियों को अभातिशप की वेबसाइट पर उपलब्ध निर्धारित प्ररूप में आवेदन करना होगा।
